8. <u>APPROPRIATION FROM RESERVES AND BUDGET REVISION FOR THE</u> 2025–2026 FISCAL YEAR

Recommend that the Board of Education approve the following Resolution:

WHEREAS, the Board of Education of the Deer Park Union Free School District has identified a budget shortfall totaling \$2,860,000 for BOCES special education services for the 2025–2026 school year; and

WHEREAS, the Board of Education is authorized under New York General Municipal Law Section 6-r and Education Law Sections 1604(36) and 1709(37) to appropriate funds from the Teachers' Retirement System (TRS) reserve, Employees' Retirement System (ERS) reserve, and the Tax Reduction reserve for budgetary needs consistent with their established purposes;

NOW, THEREFORE, BE IT RESOLVED that the Board of Education hereby authorizes the appropriation of the following amounts:

- \$1,000,000 from the TRS reserve, leaving a projected balance of \$2,275,120;
- \$1,260,000 from the ERS reserve, leaving a projected balance of \$2,153,300;
- \$600,000 from the Tax Reduction reserve, leaving a projected balance of \$672,013;

BE IT FURTHER RESOLVED that the 2025–2026 budget is amended to increase appropriations by \$2,860,000 to address the special education funding shortfall, and such amounts shall be recorded in the appropriate revenue and expenditure codes within the voter-approved budget;

BE IT FURTHER RESOLVED that appropriations from the Tax Reduction reserve shall be used exclusively for the purpose of reducing the amount of taxes that would otherwise be levied to fund the budget increase and shall not be appropriated to any specific expenditure code, in accordance with General Municipal Law § 6-e;

BE IT FURTHER RESOLVED that appropriations from the TRS and ERS reserves shall be applied solely toward the district's employer retirement contribution obligations;

BE IT FURTHER RESOLVED that the Superintendent of Schools or designee is authorized to make internal transfers from retirement contribution budget lines to special education expense lines as ordinary contingent budgetary expenses;

BE IT FURTHER RESOLVED that these actions shall not impact the current year's tax levy;

BE IT FURTHER RESOLVED that the Chief Financial Officer is authorized to take all necessary administrative actions to implement this resolution consistent with applicable laws and regulations.
